## Screens Down, Minds Up: The Case for Phone-Free Classrooms

Right now, every school has the capacity to improve student learning, attention span, and sense of belonging. We need to eliminate cell phones from the classroom. Since magic bullets don't exist, this is the closest we can get to the same results. The data paints a clear picture - cell phones have no place in any serious academic settings. Cell phones are actively harming the learning capacity of our students and they need strong school policies to help deal with the digital distraction.

With the passage of Ohio House Bill 250 every school must have an approved cell phone policy in place by July 2025. This is the perfect time to examine what will help our students the most. The bill leaves room for district flexibility, but the most effective policy will be one that totally eliminates cell phones from the classroom with a school-level policy.

What's the Buzz?

- According to a UNESCO study, a single cell phone notification causes students to lose focus for an average of 20 minutes. One vibration can derail a student for half a class and there are almost no tasks that a cell phone accomplishes better than even the cheapest computers.
- The same UNESCO study also showed that cell phones had a stronger negative impact on the learning of students who are performing below their peers. That describes the majority of the students we serve.
- A study out of Rutgers University showed that having cell phones in classrooms lowers student

end-of-course grades by half a letter. And even more interesting, that study showed that even if a student did not have a device in class but their peers did, their grades were negatively affected.

A Shining Light (That Isn't a Screen)

- At the Buxton Boarding School in western Massachusetts, students replaced their smartphones with "dumb" phones. Teachers say students started socializing more, staying after class longer to talk with their teachers, and became more engaged in extracurricular activities.
- Schools in Florida that have eliminated cell phones from the classroom have reported fewer fights, incidents in the bathrooms, and improved grades.
- A study out of Hartford, Connecticut showed that "the implementation of Yondr pouches in December 2022 corresponded with a 50% drop in office referrals and a 30% to 40% decline in suspensions at the school."

Cell phones are designed to capture our attention. Social media companies have a financial incentive to keep our students glued to their phones and they employ 1000s of engineers to keep them hooked. Putting the onus entirely on our students is an unfair burden. Students need our help disconnecting from unnecessary distractions when they are in the classroom. Their learning, social interactions, and emotional well-being depend on it.

Horizon Science Academy Middle School Students Take on Rain Barrel Art Project

Seventh-grade science students at Horizon Science Academy Middle School (HSAMS) are helping conservation through art! They recently participated in the Rain Barrel Art Project, an initiative sponsored by Save Local Waters and the Cincinnati Zoo to promote water conservation. Now in its 12th year, the project transforms ordinary rain barrels into functional art, raising awareness about their environmental benefits.

Working in small groups, students designed artwork for the barrels, with three designs selected for competition. Excitingly, one HSAMS student was chosen as a finalist, earning the school rain barrels for students to paint. These beautifully decorated barrels will be displayed at the Cincinnati Zoo in April before being auctioned off to support conservation education efforts.

This project ties into students' earlier studies on the water cycle and conservation strategies. Earlier this year, they designed 3D water conservation systems. Now, they are using art to inspire action. Rain barrels help reduce stormwater runoff, prevent flooding, and conserve water, making them a simple yet powerful tool for sustainability.



### M3 Challenge: Using Math and Data to Solve Real-world Problems

Do you have students who would be interested in participating in a transformative math competition that could earn them money for college? If so, then the MathWorks Math Modeling Challenge (M3 Challenge) may be for them! M3 Challenge is a free online contest in which high school juniors and seniors use math and data to solve real-world problems.

Participants work in teams of 3-5 students to answer an open-ended question focused on a relevant and timely issue; teams choose their preferred 14-hour window to work over Challenge weekend, this year taking place Friday, February 28 through Monday, March 3. Teams work in person at the location(s) of their choice or virtually using online collaboration tools. Scholarship awards totaling \$100,000+ will be awarded in 2025!

### Grow Your Own Scholarship

The Grow Your Own Teacher Scholarship Program is designed to help school districts across Ohio recruit their own students and staff to become teachers within the district. Recipients of the Grow Your Own Scholarship agree to teach for a minimum of four years at their home school district in exchange for a scholarship of up to \$7,500/year for four years.

Application periods will be set by the Ohio Department of Higher Education as funding is available. Leadership staff at qualifying schools are expected to pro-actively recruit their own students and employees to participate in this program. Each school district interested in participating in the Ohio GYO Teacher Scholarship Program must attest that it has difficulty recruiting and retaining qualified classroom teachers.

# What have you learned over the years about running/being a part of board meetings?

- 3. Focus on strategic discussions rather than just updates.
- 4. Leverage individual expertise by delegating tasks and encouraging board members to contribute in their areas of strength.

#### How do you solicit and retain new board members?

The best way to attract and retain new members is to look for people in your community whose values align with mission/vision of the board and who have a passion for the work.

#### What part of the school's mission do you most connect with?

### February Compliance Update

#### -Labor Law Postings

Schools should ensure they have the latest versions of the Labor Law postings to remain compliant with state and federal regulations. The most recent update to the Ohio and federal labor law posters was made effective on January 1, 2025. Specifically, the Ohio Department of Commerce updated the minimum wage posting to reflect the new rates for 2025. There were several updated and new required postings in 2024.

If you need to update postings, you can download them from the respective agency websites or purchase an all-in-one poster that includes all required postings. Free downloads of individual postings available here: Labor/Employment Law Posting Requirements for State Agencies I Department of Administrative Services

These posters (postings) must be displayed in a prominent area within the workplace to ensure that all employees have access to this important information.

-When can a Community School Board (public body) go into Executive Session and what can be discussed?

It's important to note that Executive Session can only be used for discussions or deliberations. Board members cannot vote or make decisions, those types of actions must be done in the *Open* board meeting. It does not mean the board must come out and take action on what was discussed.

The Board must make a motion to go into executive session during the board meeting by having a unanimous roll call vote and the motion must be specific in stating the statutory reason(s) for entering into executive session. Board members cannot discuss any other topics or matters before the board other than the reason/topic stated in the motion.

There is a very defined list of topics for executive session as outlined in Ohio Revised Code 121.22(G) <u>https://codes.ohio.gov/ohio-revised-code/section-121.22</u>.



#### -Updated special education model policies and procedures available

The Ohio Department of Education and Workforce updated the special education model policies and procedures to include changes to the Operating Standards for the Education of Children with Disabilities, which are now available on the Department's Operating Standards and Guidance webpage. All educational agencies must upload verification of local school board approval of policies and procedures for the 2024-2025 school year though the Monitoring System by March 30, 2025. Beginning with the 2025-2026 school year, the annual due date is Nov. 30.
